

Multifamily Energy Alliance (MEA) – 3rd Party Program

- Work with your MEA account manager to determine your eligibility and assess your property's needs.
- 2. Purchase energy-efficient equipment that meets Program specifications. Find equipment that can qualify for SoCalGas rebates by visiting energystar.gov.
- Install energy-efficient equipment with the contractor of your choice. NOTE: Installations that involve replacement of HVAC equipment are required to complete an HVAC Permit Closure Form to receive rebate payment.
- Submit your completed rebate application, including signed Terms and Conditions and required supporting documentation to your MEA account manager.

- Work with your MEA account manager to determine your eligibility and assess your property's needs.
- 2. Schedule your property's MEA Program screening to determine appropriate upgrades.
- Review the Direct Install Equipment Installation Proposal prepared for your property.
- Accept the Direct Install Equipment
 Installation Proposal and schedule your installation, the appropriate amount of time for tenant notification.
- 5. Complete any required site inspection and equipment installation verification requirements.



^{*}Customer will be required to do a copay of \$1,000 for non–DAC/HTR/Underserved Community properties and \$500 for DAC/HTR/Underserved Community properties. Comprehensive Multifamily Incentive (CoMFI) – 3rd Party Program

The CoMFI Program provides multifamily property owners and managers energy efficient solutions to help reduce energy usage and cost. The incentives are designed to help alleviate financial barriers that may be holding multifamily properties from their next energy efficiency project.

Can be incentivized up to 65% of project cost.

Eligibility Requirements

- ✓ Must have an active SoCalGas account
- ✓ Must be an existing Multifamily Property with 3 or more dwelling units
- ✓ Must be on a Multifamily Rate Code



1. Apply to the CoMFI Program

Submit your completed application to convey interest in participating in the program.



4. Reserve your energy efficiency incentive

A CoMFI Program team member will work with your property and selected contractor to finalize the project's scope of work and reserve incentive funds.

Program Process



2. No-cost energy assessment

A CoMFI Program team member will schedule and conduct a no-cost energy assessment of the property to identify potential upgrade opportunities.



3. Select your installation contractor

Select your own licensed contractor, or program staff can provide a list of participating licensed contractors to choose from.



5. Notice to proceed or start construction

Once the eligible scope of work has been approved, a CoMFI Program team member will provide a notice to proceed with construction.



6. Project completion and closeout

When construction is complete, a CoMFI Program team member will perform an onsite inspection and collect the necessary program documents. Subject to the Terms and Conditions, once all documentation has been received and verified, a check will be issued to the designated payee.

Incentive tiers are based on the level of energy efficiency achieved in the property by installing energy efficiency equipment. Customers must achieve a minimum of 5% energy savings in their multifamily property to receive an incentive.

Customers who fall between tiers will be incentivized on the lower tier, for example: If a customer archives 19% energy savings, they will receive a Tier 3: 15% natural gas savings incentive of \$570 per dwelling unit.

The Comprehensive Multifamily Incentive (CoMFI) Program provides multifamily property owners and managers energy efficient solutions to help reduce energy usage and costs. CoMFI offers no-cost energy audits, property-specific energy reports, and incentive reservations for qualifying whole-building retrofits.

HOW THE PROGRAM WORKS

1. APPLY FOR THE PROGRAM

Submit this application form to express interest in participating in the CoMFI program. This document also allows program personnel to visit the property.

2. CONDUCT A PROPERTY ENERGY ASSESSMENT

A program representative will conduct a no-cost energy assessment to identify potential energy efficiency upgrades for your building's existing natural gas equipment and related systems.

3. SELECT AN INSTALLATION CONTRACTOR

Select a qualified, licensed contractor to perform the installation of your energy efficiency project. The program will provide a list of licensed contractors for customers that need assistance selecting a qualified contractor.

4. RESERVE YOUR ENERGY EFFICIENCY INCENTIVE

Once a scope of work that meets program requirements has been selected and a contractor proposal has been received by the program, you will be provided with a reservation form listing the scope of work. The property owner or authorized agent will need to sign and return the reservation form to reserve funds for their project.

5. NOTICE TO PROCEED

Once the project funds have been reserved, you will be provided with a Notice to Proceed. By signing and returning the Notice to Proceed to program representatives, you will receive approval to commence the scope of work specified in the reservation form.

6. PROJECT COMPLETION

A final verification of the installed equipment will be conducted to ensure consistency with the scope of work listed in the reservation form. Program representatives will work with the customer and contractor to obtain the necessary closeout documents. Once the submitted documents have been reviewed and approved, the incentive will be disbursed.
